



YSB 3 Designs 2010 Destination Beach Wedding Sweepstakes - Official Rules

1. Sponsor: YSB 3 Designs, P.O. Box 2213, Rancho Cordova, CA 95741
2. No Purchase Necessary
3. Entry: You must be 18 years of age or older to be eligible for the Sweepstakes. You must fulfill the terms of these Sweepstakes within one year of the drawing date. Limit one entry per person. To enter, complete an official entry form available at the YSB 3 Designs exhibit booth at The Dream Wedding Show on February 28, 2010, held at the Cal Expo from 11AM to 3PM. You will be asked to provide your first and last name, address, telephone number, and e-mail address (if available). The Sweepstakes begins at 11:01 AM PST February 28, 2010 and ends 3:01 PM PST February 28, 2010. All entries must be received by 3:01 PM PST on February 28, 2010. **LIMIT ONE ENTRY PER PERSON.** Multiple entries will be disqualified. Sponsor assumes no responsibility for lost, late, misdirected, illegible, or mutilated entries or for any computer, online, telephone, technical or other malfunctions that may occur. All entries become the property of Sponsor and will not be returned to entrant.
4. Winner Selection: Potential prize winner will be selected in a random drawing to be held at "The Dream Wedding Show" on February 28, 2010 at The Dream Wedding Show following the 2:30 P.M. Bridal Fashion Show. Winner need not be present to win. The potential winner will be notified by email, mail or phone. The potential winner will be required to sign and return to Sponsor, within ten days of the date notice or attempted notice is sent, an Affidavit of Eligibility, Liability & Publicity Release in order to claim his/her prize. If the potential winner cannot be contacted, or fails to sign and return the Affidavit of Eligibility, Liability & Publicity Release within the required time period, potential winner must forfeit any prize.
